City of Hudson Water Conservation Plan 2022 Update

A. Purpose

This water conservation plan is compiled with the intent of complying with Texas Water Development Board requirements pursuant to 31 TAC § 375.43 and 363.15. This plan applies to the customers of the City of Hudson Wastewater Collection System, proposed under the corresponding CWSRF application submitted in September 2016.

B. Overview

The City of Hudson owns and operates a wastewater collection system and treatment facility for the incorporated limits of the City of Hudson and portions of the immediately surrounding area. Though this specific system does not directly provide or manage water supplies, the City of Hudson recognizes that water conservation is highly relevant to the area, and measures should be made to encourage water conservation for users of their wastewater system. To this end, they plan to utilize the contact provided through this system to educate customers regarding water conservation.

C. Targets and Goals

As part of the water conservation plan the City of Hudson will:

1. Promote water conservation by providing material and water conservation brochures at City Hall at no cost to the public. These will be obtained from reliable sources such as the Texas Water Development Board, Texas Commission on Environmental Quality, Hudson Water Supply Corporation, and other resources.
2. At least **six times** per year, publish water conservation guidelines and the importance of water conservation on the back of the City of Hudson Utility Systems utility bill for the residents of the City of Hudson.
3. Make information on water conservation available on the City's website and include links to applicable agency websites and water conservation resources.

D. Tracking Implementation and Effectiveness of Goals

In an ongoing effort to evaluate and improve upon the efforts of the City in regards to water conservation, City staff shall track targets and goals by using the following procedures:

1. Maintain logs for tracking brochures and mail outs on utility bills.
2. Keep inventories for supplies on hand and brochures distributed on a semi-annual basis.

E. Means of Implementation

1. During the first six months after the Water Conservation Plan is approved, City staff will complete the following:
 - a. Identify and obtain water conservation materials.
 - b. Provide the water conservation materials to the public as mentioned in the plan.

2. During the second six months following initial implementation:
 - a. Provide water conservation information to be included on the utility bill to customers.
 - b. Establish inventory of water conservation materials.
 - c. Provide material and water conservation brochures at City Hall.

3. During the next year and every year thereafter:
 - a. Provide water conservation guidelines and the importance of water conservation notice to residents via the utility bill at a minimum of **six times** a year.
 - b. Continue to provide water conservation materials to the public at City Hall and on the City's website. **Add water tips to the Digital sign located at 3458 Ted Trout quarterly.**
 - c. **Prepare an annual report for presentation to the City Council to include, number of brochures, materials, advertisements.**
