Action: Mayor Pro Tem George Knight moved to approve the Purchase of a Interceptor Utility Vehicle for a 5yr. payment plan. Councilmember Joann Novak seconded the Motion. Four (4) for and none (0) opposed - Motion Passed.

 DISCUSSION AND ACTION to approve and Grant a Variance for Rustic Pines Subdivision on FM1194.
